PARKING RATE INCREASE

OCTOBER 10, 2012

AGENDA ITEM: The Director of Airports is requesting approval to increase the rates paid by the of the parking patrons of the parking lots at Lambert-St. Louis International Airport® in accordance with the schedule set out in Attachment 1, entitled "Proposed Changes."

APPROVAL

REQUIRED: Airport Commission, pursuant to Section 18.08.070 of the Revised Code of the City of St. Louis 1994.

DESCRIPTION: Parking rates at the Airport owned "Super Park" public parking facilities will be adjusted and increased as set out in the Attachment 1. The new parking rates will be effective November 1, 2012, with the exception of the new Lot C Airline Employee Rate which shall be effective June 1, 2012.

Recommendation: We recommend that the Airport Commission approve this motion.

Parking rates at the four surface Public Parking facilities will be increased as set out in the Attachment 1.

Both changes in the Public Parking Rates will be effective as of August 1, 2007. The maximum Public Parking Rate in the garages and was approved by me along with the Overnight Rates on behalf of the Airport Commission pursuant to an authorization motion set out below that was approved by the Airport Commission on December 5, 2001.

AUTHORIZATION TO APPROVE PUBLIC-PARKING RATES

The Airport Director, in the best interest of the City and traveling public, is hereby authorized to increase or decrease parking rates for all of the various parking facilities at Lambert-St. Louis International Airport in amounts that do not exceed fifty percent

(50%) of the current rates, along with the necessary adjustments to the incremental rates and times, as set out in Exhibit "A". The Director of Airports will inform the Airport Commission on a quarterly basis of such rate changes.

Description:

Establishing a new rate category for "**Terminal 1 TSA Parking.**"

The "**Terminal 1 TSA Parking Rate**" of \$155.00 per month per pass card will be effective December 1, 2016.

The Terminal 1 TSA Parking Rate of \$155.00 per month will only apply to Transportation Security Administration employees participating in an agreement arranged by a third party engaged by the TSA and ABM Parking Services, the City's agent. The rate will only be offered if 100 or more TSA employees participate.

The Airport Director may adjust Terminal 1 TSA Parking Rate in amounts that do not exceed 50% of the initial Terminal 1 TSA Parking Rate.

TSA employees will be limited to the Red Level of the Terminal 1 garage.

Approval
Required:

Airport Commission, pursuant to Section 18.08.070 of the Revised Code of the City of St. Louis 1994.

Recommendation:

We recommend approval by the Commission of the establishment of a new rate category for Terminal 1 TSA Parking (Red Level only) at \$155.00 per month per pass card, effective December 1, 2016 and authorizing the Director to adjust the Terminal 1 TSA Parking Rate in amounts that do not exceed 50% of initial rate.
