

An ordinance authorizing the Mayor and the Comptroller of the City of St. Louis in behalf of said City to enter into and execute a Cooperation Agreement by and between the City of St. Louis, a municipal corporation of the State of Missouri and McDonnell Douglas Corporation, a corporation organized and existing under the laws of the State of Missouri, whereby the parties agree to assist each other in connection with fire fighting, crashes, rescue operations and other emergencies at St. Louis International Airport and on the property of McDonnell Douglas Corporation and also at places adjacent thereto, and containing an emergency clause,
BE IT ORDAINED BY THE CITY OF ST. LOUIS, AS FOLLOWS:

Section One. The Mayor and the Comptroller of the City of St. Louis in behalf of said City shall be and are hereby authorized to enter into and execute a Cooperation Agreement by and between said City and McDonnell Douglas Corporation.

Section Two. Said Cooperation Agreement shall provide substantially as follows:

COOPERATION AGREEMENT

The CITY OF ST. LOUIS (City) acting through the St. Louis Airport Commission, the St. Louis Fire Department and other agencies of the City, and McDONNELL DOUGLAS CORPORATION (MDC) agree to assist each other in connection with fire fighting, crashes, rescue operations and other emergencies at St. Louis International Airport (Airport) and on the property of MDC and also at places adjacent thereto, upon the following terms:

1. Assistance will be rendered only if the assisting party can release emergency forces and equipment from its own needs.
2. The assisted party shall indemnify and save the assisting party, its officers, agents and employees, harmless from all losses, costs, fees, expenses and damages because of bodily injury (including death), actual or alleged to any person including, but not limited to, any employee of either party, and including any third party and because of damage to property,

actual or alleged, including, but not limited to, the property of any employee of either party, and including the property of any third party, if such bodily injury or property damage is caused by the acts or omissions, negligent or otherwise, of the assisting party, its agents or employees.

3. This Agreement may be terminated at any time by either party by notice in writing to the other.
