### AT ST. LOUIS LAMBERT INTERNATIONAL AIRPORT

THIS FIRST AMENDMENT entered into this 29<sup>th</sup> day of May, 2018 ("First Amendment"), by and between the City of St. Louis, a municipal corporation of the State of Missouri ("City") and Vanderlande Industries, Inc. ("Consultant") is an amendment to the Operation & Maintenance of Airport Baggage Handling System Services Agreement dated December 17, 2015 (the "Agreement").

# WITNESSETH, THAT:

WHEREAS, the City and Consultant are parties to the Agreement; and

WHEREAS, the City and Consultant desire to amend the Agreement to their mutual benefit.

NOW, THEREFORE, for and in consideration of the promises, and of the mutual covenants and agreements herein contained, and other valuable considerations, the City and the Consultant agree that the Agreement shall be amended as follows:

### **SECTION 1**

The Effective Date of this First Amendment shall be November 1, 2018.

### **SECTION 2**

Page one (1) of the Agreement is hereby deleted in its entirety and replaced with page 1 of this First Amendment, excluding the words "First Amendment To" from page 1 of the First Amendment.

### **SECTION 3**

Section 3 of the Agreement entitled "Fees" is hereby amended by incorporating fees for the term of January 1, 2018 to December 31, 2019 as shown below:

Section 5 of the Agreement entitled "Term" is hereby amended by extending the term of the Agreement by twelve (12) months so that the Agreement shall now end on December 31, 2019.

### **SECTION 5**

Delete Section 9.E from the Agreement and replace it with the new Section 9.E below.

"D. The total Contract Not-To-Exceed Amount of this Agreement is Eleven Million One Hundred Ninety-Four Thousand Two Hundred Fifty-Four Dollars and Forty-Three Cents (\$11,194,254.43).

#### **SECTION 6**
