FIRST AMENDMENT TO SECURITY GUARD SERVICES AGREEMENT FOR
ST. LOUIS LAMBERT INTERNATIONAL AIRPORT

THIS FIRST AMENDMENT entered into this *8th* day of *October*, 2018 (“**First Amendment**”), by and between the City of St. Louis, a municipal corporation of the State of Missouri (“**City**”) and Whelan Security Co. (“**Contractor**”) is an amendment to the Airport Security Guard Services Agreement dated October 10, 2017 (the “**Agreement**”).

WITNESSETH, THAT:

WHEREAS, the City and Contractor are parties to the Agreement; and

WHEREAS, the City and Contractor desire to amend the Agreement to their mutual benefit.

NOW, THEREFORE, for and in consideration of the promises, and of the mutual covenants and agreements herein contained, and other valuable considerations, the City and the Contractor agree that the Agreement shall be amended as follows:

SECTION 1

The Effective Date of this First Amendment shall be August 1, 2018.

SECTION 2

Page one (1) of the Agreement is hereby deleted in its entirety and replaced with page 1 of this First Amendment, excluding the words "First Amendment To" from page 1 of the First Amendment.

SECTION 3

Delete Section 4.0D from the RFP and replace it with the new Section 4.0D below.

"D. The total Contract Not-To-Exceed Amount of this Agreement is Eighteen Million Eight Hundred Thirty-Nine Thousand Seven Hundred Eighty Seven Dollars and Six Cents (\$18,839,787.06)."

SECTION 4

All other terms and conditions of the Agreement not inconsistent with this First Amendment are unchanged and are hereby ratified and approved and will remain in full force and effect.
