**THIS FIRST AMENDMENT** entered into this 2<sup>nd</sup> day of March, 2018 (“**First Amendment**”), by and between the City of St. Louis, a municipal corporation of the State of Missouri (“**City**”) and Unison Consulting, Inc. (“**Consultant**”) is an amendment to the Airport Business Services Agreement dated June 2, 2015 (the “**Agreement**”).

**WITNESSETH, THAT:**

**WHEREAS**, the City and Consultant are parties to the Agreement; and

**WHEREAS**, the City and Consultant desire to amend the Agreement to their mutual benefit.

**NOW, THEREFORE**, for and in consideration of the promises, and of the mutual covenants and agreements herein contained, and other valuable considerations, the City and the Consultant agree that the Agreement shall be amended as follows:

## **SECTION 1**

The Effective Date of this First Amendment shall be July 1, 2018.

## **SECTION 2**

Page one (1) of the Agreement is hereby deleted in its entirety and replaced with page 1 of this First Amendment, excluding the words "First Amendment To" from page 1 of the First Amendment.

## **SECTION 3**

Section 5 of the Agreement entitled "Term" is hereby amended by extending the term of the Agreement by twelve (12) months so that the Agreement shall now end on June 30, 2019.

## **SECTION 4**

Delete Section 9.D from the RFP and replace it with the new Section 9.D below.

"D. The total Contract Not-To-Exceed Amount of this Agreement is One Million Seven Hundred and Ninety Thousand Dollars (\$1,790,000.00).

## **SECTION 5**

All other terms and conditions of the Agreement not inconsistent with this First Amendment are unchanged and are hereby ratified and approved and will remain in full force and effect.
