THIRD SUPPLEMENTAL AGREEMENT**

THIS THIRD SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "**Commission**") and the City of St. Louis, Missouri (hereinafter, "**City**").

WITNESSETH:

WHEREAS, the Commission and the City previously entered into a Maintenance Agreement for the Lindbergh Tunnel on May 18, 2006 as amended by the First Supplemental Agreement dated May 21, 2009 and the Second Supplemental Agreement dated February 15, 2012 (hereinafter, "**Original Agreement**"); and

WHEREAS, the Original Agreement commenced on July 1, 2006 and is set to expire on April 30, 2012; and

WHEREAS, the parties wish to extend the duration of the Original Agreement as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Third Supplemental Agreement, the parties agree as follows:

(1) **EXTENSION OF ORIGINAL AGREEMENT**: The parties hereby agree to extend the duration of the Original Agreement by 36 months from February 28, 2015 through February 28, 2018 under the same terms and conditions contained in the Original Agreement.

(2) **ORIGINAL AGREEMENT**: Except as modified, amended or supplemented by this Third Supplemental Agreement, the terms of the Original Agreement shall remain in full force and effect and shall extend to this Third Supplemental Agreement.
