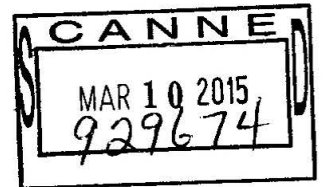

FIRST SUPPLEMENTAL AGREEMENT**

THIS FIRST SUPPLEMENTAL AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "**Commission**") and the City of St. Louis, Missouri (hereinafter, "**City**").

WITNESSETH:

WHEREAS, the Commission and the City previously entered into a Maintenance Agreement for the Lindbergh Tunnel on May 18, 2006 (hereinafter, "**Original Agreement**"); and

WHEREAS, the Original Agreement commenced on July 1, 2006 and is set to expire on June 30, 2009; and

WHEREAS, the parties wish to extend the duration of the Original Agreement as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this First Supplemental Agreement, the parties agree as follows:

(1) **EXTENSION OF ORIGINAL AGREEMENT**: The parties hereby agree to extend the duration of the Original Agreement by 34 months from July 1, 2009 through April 30, 2012 under the same terms and conditions contained in the Original Agreement.

(2) **ORIGINAL AGREEMENT**: Except as modified, amended or supplemented by this First Supplemental Agreement, the terms of the Original Agreement shall remain in full force and effect and shall extend to this First Supplemental Agreement.

IN WITNESS WHEREOF, the parties have entered into this First Supplemental Agreement on the date last written below.

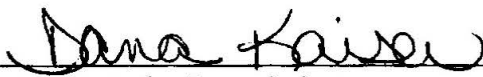

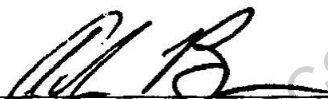
